Thank you for your request for information that was received on 7 August 2023 concerning I am writing to request the written reasons why two bidders confirmed that they were withdrawing from the procurement process for the Ladywood Regeneration Scheme.

'4.11 On 14th September 2020, after four dialogue meetings, one of the bidders confirmed that they were withdrawing from the process. Likewise, on 20th November 2020, (after six dialogue meetings) another bidder also withdrew from the procurement. Written feedback was received from both organisations stating that their reasons for withdrawing were not a consequence of the procurement process.'
